- > INCOMPLETE APPLICATIONS WILL NOT BE CONSIDERED.

LegalWise offers a limited number of bursaries to its Members and/or their children. It reserves the right to accept or decline applications at its discretion and in accordance with its own internal decision-making process.

Instructions for submission of application forms:

- > Applications will only be considered if they are completed in full and submitted with all supporting documentation.
- > Please do not send original documents; certified copies are sufficient. SAPS or SA Post Office can certify your documents.
- > Affidavits can be made at your local Police Station.

Selection Criteria:

*The following criteria will be strictly adhered to:*

- > Bursaries are not offered to first year students. Only students who have already completed, or are in the process of completing their first year of study will be considered. No exceptions will be made.
- > Bursaries are not offered for part-time or correspondence studies. No exceptions will be made.
- > You must currently be registered as a full-time student at an approved University enrolled to study one of the following degrees:
  - LLB
  - BCOM (Law)
  - BA (Law)
  - BCOM (Accounting)
  - BCOM (Human Resource Management)
  - BCOM (Management)
  - BCOM (Industrial Psychology)
  - BIS (Information Science)
  - BSc/BCom (Informatics)
- > You must have achieved at least a "C" aggregate (60 %) in your previous year of study. No exceptions will be made.
- > You should be able to speak, read and write English and at least one other official language.
- > In addition to academic achievement you should display determination, a positive attitude and the commitment to succeed. You should also demonstrate initiative and have the ability to work in a team.
- > You should display good interpersonal and communication skills.
- > Shortlisted candidates will be required to go to their nearest LegalWise Branch for an interview before the end of the current year.
- > Bursaries are only awarded for the year following the one in which the application was received.
- > You, your Parent(s) or Legal Guardian must be a fully paid-up Member of LegalWise. This Membership must have been active for at least two years prior to applying. No exceptions will be made.

Supporting Documentation which MUST be included with the Bursary Application Form:

- > A copy of your final Matric results and a complete academic transcript from your tertiary institution, including a copy of your latest exam results for the first semester.
- > A copy of your latest student account from the University reflecting all transactions.

- > A motivation / essay giving details about yourself and why you should be selected as a LegalWise Bursary Holder. **Please limit your essay to 750 words.**
- > Your Parent, Legal Guardian or friend may also write a letter of recommendation for you.
- > Proof of income\* for both your Parent(s), Legal Guardian or Spouse (e.g. \*payslip, letter from employer, proof of SASSA grants, sworn affidavit or tax return statement not older than 3 months).
- > A certified copy of your South African ID (applicant) and certified copies of the IDs of your Parent(s) or legally appointed Guardian.
- > Proof that you are the biological or adopted child of a LegalWise Member or under the legal guardianship of a LegalWise Member (birth certificate of the child of principal Member, marriage certificate, copy of Membership card, court order granting guardianship) or a LegalWise Member yourself.
- > Confirmation from the University that you are currently registered to study one of the approved degrees previously listed.

What the Bursary covers:

- > The Bursary is a partial bursary awarded to cover annual registration and tuition fees to the maximum value of R40 000.
- > The payment of fees is conditional on academic performance during the year as well as the timely submission of all results and accounts to the Bursary Administrator.
- > The Bursary may be renewed on an annual basis on condition that the Bursary Holder demonstrates adequate academic performance, completes and performs adequately during their required vacation work at a LegalWise Branch and complies with the terms and conditions of their LegalWise Bursary Agreement.
- > No payment will be made towards historical debt in respect of studies already completed or for subjects you failed to complete in the previous year of study.

Bursary Holder Obligations:

- > The Bursary Holder is required to complete their studies in the minimum prescribed number of years as determined by the University at which they have enrolled. Failure to do so may result in the Bursary Holder being required to repay the amount of the Bursary awarded in full to LegalWise.
- > Bursary Holders will be required to work at the LegalWise Branch nearest to them during their University vacation times. Vacation work amounts to 5 weeks per annum: two weeks during the June vacation and three weeks during the December vacation. Training will be provided and Bursary Holders will be remunerated for this time.
- > Bursary Holders studying BCOM (Accounting), BCOM (Human Resource Management), BCOM (Management), BCOM (Industrial Psychology), BIS (Information Science) or BSc/BCom (Informatics) will be required to fulfill their vacation and service level obligation in Roodepoort, Gauteng. All travel and accommodation costs will be for their own account.
- > Bursary Holders will be required to fulfill a service level obligation with the Company following the completion of their degree. This will be 6 months paid service for every year for which the Bursary was awarded.
